Drum Runners provides the following activities:

Creative therapies consisting of music workshops, sound therapies, creative writing and music technology.

This Policy will operate within the ethos and principles of Drum Runners to promote equality of opportunity and anti-discriminatory practice towards all persons (freelance staff, students, volunteers including trustees and service users).

Drum Runners is committed to protecting the health and safety of its freelance staffs, students, volunteers or service users and all others with whom our work brings us into contact. Drum Runners's policy is to aim to provide a safe and healthy working environment for everyone.

Drum Runners recognises its responsibilities under the Health and Safety at Work Act and other related legislation. Drum Runners believes that communication, co-operation and consultation with all is essential and a copy of this policy is available to each person.

Action may be brought if there is neglect or abuse of health and safety requirements.

Responsibilities:

The final overall responsibility for the health and safety rests with the Workshop Facilitator(s). They will:

- Have discussed, researched, produced, adopted and distributed this Health and Safety policy.
- Discuss Health and Safety issues at least once a year.
- Keep up to date with responsibilities on health and safety and revise this policy as necessary.

- Answer questions from anyone about the policy and related matters.
- Ensure the day to day compliance with Health and Safety.
- Ensure as far as is reasonably possible any premises being used for Drum Runners's activities comply with the Workplace regulations, the Offices Shops and Railway Premises Act and other relevant legislation.
- Receive reports from anyone on accidents, near misses and defects and report any relevant incidents to the necessary authorities (under RIDDOR - Reporting of Injuries, Diseases and Dangerous Occurrences Regulations).
- Liaise with any bookers and venues being used to ensure safe working practices, and the safety of participants and audiences for Drum Runners's activities.

All persons need to:

- Take reasonable care for the health and safety of him / herself / them self and all others who may be affected by his or her acts or omissions.
- Follow any safety instructions given.
- Not to operate any machinery unless proper training has been given.
- Co-operate with other persons in the operation of the Health and Safety policy.
- Not interfere with or misuse anything provided in the interests of health and safety.

- Follow procedures for fire, first aid, hazardous substances (if applicable), security and the use of any equipment.

- Ensure that they are aware of the relevant health and safety representative(s) on sites where Drum Runners work is taking place.

- Report any accident, danger, defect or near miss immediately to the relevant health and

safety representative(s) on sites where Drum Runners work is taking place and ensure that is noted in the relevant accident and incident book/s as appropriate.

- Report, as soon as is possible, any accident, danger, defect or near miss to the senior Drum Runners person who is present at a particular activity and they in turn they must ensure that the lead Workshops Facilitator of Drum Runners (Paul Midgley) is informed at the earliest opportunity.
